WAY TO PAY PLAN FOR 2021

You are kindly requested to take note of the following:

At a parents meeting on 04 November 2020, it was accepted that the fees for 2021 academic year would be R1600-00 per learner from Grades 1 to Grade 7. Grade R learners will pay R1800 per annum

METHODS OF PAYMENT

1. A full payment of R1800 (Gr R) / full payment of R1600-00 (Gr 1-7)
2. Part payment :
 - The 1st instalment of **R1000-00 (Gr R admission)** and balance of R800-00 must be paid on 27 January 2021 (Gr R Final payment)
 - The 1st instalment of **R800-00 (Gr 1-7)** on readmission.
 - The 2nd instalment of **R200-00** is due by **26February 2021**
 - The 3rd instalment of **R200-00** is due by **31 March 2021**
 - The 4th instalment of **R200-00** is due by **30 April 2021**
 - The 5th instalment of **R100-00** is due by **31 May 2021**
 - The **final** instalment of **R100-00** is due by **30 JUNE 2021**

- Exemption (total , partial, conditional)is subject to a formula herein as well as relevant documentation.
- All decisions will be taken by the School's Governing Body and the applicant will be informed in writing 7 days after the decision is taken.
